Call to Order: The meeting was called to order at 9:33 a.m. by President Teresa Kirkorian.

**Vice President:** Vice president Kim Gould thanked Ann Caldwell for providing the delightful refreshments and Ann Caldwell thanked Kim Gould for the lovely Halloween decorations.

**Approval of the Minutes:** Desiree Ward, on behalf of Suzanne Crosina-Sahm, announced the minutes of the August 28, 2023 board meeting were published in the September Fig Leaf. Teresa Kirkorian asked if there were any additions, corrections or deletions. Hearing none, Diane Hill moved the minutes be approved as published. Martha Stewart seconded the motion and the minutes of the September meeting were approved as submitted.

**Treasurer's Report**: In the absence of Treasurer Susan Simpson, Teresa Kirkorian reported; as of September 24, 2023, there is total of \$200,448.51 in our accounts. We had expenditures of \$11,463.05 which includes two luncheons and the printing of the handbooks.

**Corresponding Secretary's Report**: Liz Conner reported no correspondence was sent in September. One donation request was received from Hope Now, and a thank you letter was received from the Girl Scouts. A magazine was received from Uline and a year-end report from Valley Center for the Blind.

**President's Report**: President Teresa Kirkorian thanked everyone who participated in the September luncheon, saying she felt we got a good deal of business done and look forward to a busy October.

#### STANDING COMMITTEE REPORTS:

**Scholarships:** Chair Pam Vogel reported her committee met September 13, 2023, to discuss nursing scholarships. There were 16 \$500 scholarships distributed in the last funding cycle and all the recipients are invited to the October general meeting luncheon. One recipient graciously accepted our invitation and will attend, and the rest are busy working. On behalf of the Scholarship Committee Chair Pam Vogel made a motion that the scholarship amount for Fresno Community College nursing students be increased from \$500 to \$1000 per student for the 2023-2024 club year, to grant twelve recipients a total award of \$12,000.00. Ann Caldwell seconded the motion. There was a brief discussion, a vote was taken and the motion carried.

**Bylaws:** Chair Maureen Boyle reported her committee has reviewed the bylaws and will propose a change to state that regular luncheon meetings shall be held September through May. There will also need to be a

**Oktoberfest**: Chair Irene Weigand reported that her committee is getting ready for Oktobefest on Saturday, October 14, 2023. There will be lights strung in the biergarten, plenty of delicious German food, beer and entertainment by The Polkateers. The committee hopes to sell 30 more tickets. Members are welcome to pay by credit card. President Teresa Kirkorian and encouraged all members to attend.

**Makers Market**; Desiree Ward reported on behalf of Chair Nancee Smith. The Makers Market will take place at the FGWC parking lot Saturday, November 18, 2023, from 9 a.m to 3 p.m. Vendor spaces sold out in a remarkably short time. We actually had to make room for a couple extra vendors who submitted their payments in a timely manner. We have 40 wonderful artisans coming and are still looking for a food truck. - Do not open any links in texts or emails unless it is a known and trusted sender.
- If you don't believe the sender is who is stated in the email hover your mouse over the "Sender" field and a box will pop up showing you the actual sender's email address. In the case of Teresa's fraudster, the email address is bob456@gmail which is NOT TERESA.
- Do not provide personal information on-line or over the phone.
- If you don't know if a text or email is valid just take a moment to call the sender to confirm before sharing any information.

Several members shared their personal experiences with attempted scams and lessons learned:

- Check your bank accounts regularly especially during the holidays when scammers can slip money out or your account without you noticing the withdrawal.
- Xfinity will not call you to request a check to be sent.
- Your grandchildren are probably not in jail in Mexico.
- Microsoft will not call you to fix your mother-board.

The members in attendance sang a joyous happy birthday song to Delores O'Neal.

**Treasurer's Report**: Treasurer Susan Simpson reported that as of the end of September, the B of A checking balance is \$92,479.15. The Endowment Fund is \$69,419.58, the Building Fund is \$31,380.24, and the Memorial Fund is \$13,169.54. The total cash on hand is \$206,448.51. Income was \$4,270 and expenses were \$11,463.05.

**Corresponding Secretary Report**: Corresponding Secretary Liz Conner repored that we received one donation request from Hope Now, no invitations, one thank you note from the Girl Scouts, and three subscriptions.

#### STANDING COMMITTEES

**Scholarship**: Chair Pam Vogel reported that she and her committee met in September and her committed recommends raising the dollar amount of the scholarships we provide to nursing students. Pam moved that for the 2023-2024 program year, we increase our scholarship amount from \$500 per scholarship to \$1,000 and provide 12 scholarships for a total of \$12,000. Diane Hill seconded the motion, and the motion passed.



- 1. Bring up the FGWC website on your phone's or iPad's internet browser.
- 2. At the bottom of the page you see a square with arrow pointing up. Click on it.
- 3. Click on "Add to Home Screen".

That's it! You're done. Just click on the icon whenever you want to check the webpage.



#### For Android devices:

- 1. Bring up the FGWC website on your phone's internet browser.
- 2. Touch the apps icon to display the apps drawer.
- 3. Long press the app icon you want to add to your home screen
- 4. Drag the app to the home screen page, lifting your finger to place the app
