Fig Garden Woman's Club Board Meeting Minutes January 8, 2024

Call to Order: The meeting was called to order at 9:39 a.m. by President Teresa Kirkorian.

Vice President's Report: Vice President Kim Gould thanked LuAnn Joy and Mary Lopez for providing the delicious refreshments. She reminded chairs of events that they need to provide a report by February 1st.

Second Vice President: Second Vice President Desiree Ward reported that this month's speaker will be Matt Dildine, director of The Fresno Rescue Mission City Center.

Treasurer's Report: Treasurer Susan Simpson reported; that as of December 31, 2023, our overall financial assets are \$223,466.17 in our accounts. Our checking account balance is \$103,807.85. Endowment Fund balance is \$74,516.09, Building Maintenance Fund is \$31,966.58 and Memorial Building Fund is \$13,175.65. In December we had income of \$6,314 and expenses of 6,422.53, that is because all of the expenses from Gala came in in January. . Net for the Gala was\$4,897.96. Santa's House was \$2,302.28, and Maker's Market was \$1,828. For the month of December we netted \$9,028.24 that will go to our community donations and scholarships. She congratulated our members who chaired those successful events.

Corresponding Secretary's Report: Corresponding Secretary Liz Conner reported that no correspondence was sent, we received five donation requests from: Children's Home Society of California, Hope Now, Valley Center for the Blind, Evangel Home, and Fresno Council on Child Abuse Prevention. We received one invitation -- a save the date for the Hope Now Annual Banquet on February 29. We received five newsletters, magazines, and year-end reports and three holiday cards.

Approval of the Minutes: Recording Secretary Suzanne Crosina-Sahm announced the minutes of the December board meeting were published in the January Fig Leaf and asked if there were any additions, corrections or deletions. Tracy Jensen moved that the minutes be approved and Donna Strickler seconded the motion. The minutes were approved unanimously.

District Report: District Representative Eleantor Rojas reported that she needs a copy of our financial report to bring to the district meeting this Thursday so she can report on how much we have earned and share fundraising ideas and information. The State Convention of the district will be in Visalia this April and she recommended that Teresa and Kim visit on at least one day. Susan reported information from the December District board meeting. The Wasco chapter is celebrating their 100-year anniversary with an open house on February 13. There is an invitation on the back desk. The Yosemite District has disbanded, but is joining the San Joaquin Valley District.

President's Report: Teresa thanked Eleanor for representing our club and for all the time she puts into the job. She thanked Desiree for helping take down the Christmas decorations, and the December chairs and committees for all their efforts. She shared that in November the State Center Community College District honored Fig Garden Woman's Club at the Heritage Society dinner for the nursing scholarships we provide to their students. We have given over \$100,000 in scholarships to their students. Our board represented the club at a lovely dinner and they presented us with a plaque that we will display in the clubhouse. They also pinned the members who were at the dinner and provided us with extra pins if any of you would like one.

Nominating Committee: Chair Mary Vaughan read the bylaws pertaining to nominating and elections in Section 13 of our handbook. Today we will nominate two members from the board and at the January General Meeting the club will elect a nominating committee from the floor. She will meet with the committee after the general meeting to set a date for the nominating meeting. Teresa opened the floor to nominate board members to the nominating committee. Judy Boro's
Brownie
Recipe

INGREDIENTS

16 tbsp (2 sticks) unsalted butter,
cut into 8 pieces

6 oz. unsweetened chocolate,
finely chopped

2 cups sugar

Pinch salt

4 eggs, at room temperature

2 tsp vanilla

1 1/2 cups all purpose flour, sifted

1 1/2 cups bittersweet chocolate
chips, semi-sweet chocolate chips

DIRECTIONS:

Pre-heat oven to 350 degrees. Lightly grease a 9-inch square baking pan.

In a saucepan over low heat, combine butter and unsweetened chocolate. Heat, stirring often until melted, about four minutes. Remove from heat and stir in sugar and salt. Add eggs and vanilla and stir until well blended. Sprinkle the flour over the mixture and stir until just blended. Stir in the chips.

Pour batter into the prepared pan and spread evenly. Bake until toothpick inserted into the center of the brownies comes out almost completely clean, 40 to 45 minutes. Do not over bake.

Cool completely and cut into 2 1/2-inch squares. Makes 16 large brownies.






