



#### Fig Garden Woman's Club Board Meeting Minutes November 3, 2025

**Call to Order:** The meeting was called to order by President Desiree Ward at 9:30 a.m. A quorum was present.

**First Vice President:** First Vice President Debbie Reuland thanked Members Kim and Riley Gould for providing the snacks and decorations.

**Approval of the Minutes**: Recording Secretary Charlotte Zylka Singer informed those present that the October 6, 2025 board meeting minutes were disseminated by President Desiree Ward by email. There were no additions or corrections. Member Lillan Weiland made a motion to approve the minutes as written which was seconded by Member Suzy Wren. The motion was voted on, and the minutes were approved.

**Treasurer's Report**: Treasurer Susan Simpson reported that the Club's B of A checking account, as of October 31, 2025, had a balance of \$32,350.83 and the investment accounts had a balance of \$151,668.09 for a total of \$184,018.92. Income for the month of October was \$5,312.50 and expenses were \$9,341.36 for a net negative balance of \$4,028.86. Susan further reported that the final income from Maker's Market was \$1,955, income from handbook ads was \$1,281.25, and income, as of October 31, 2025, from Trash to Treasure was \$2,085.09.

**Corresponding Secretary**: Corresponding Secretary Tamara Hargrave informed those present that in October 2025 the Club received eight donation requests and one invitation from New Wrinkles: Step into the Holidays, to be held on November 22nd and 23rd, at Fresno City College.

President's Report: President Desiree Ward welcomed Member Barb Moen back from Minnesota and thanked her for all of the work she did for the Club over the summer. Desiree also thanked Member Teresa Kirkorian for opening her house for the October Get Acquainted Coffee and Member Nancee Smith for her success with Maker's Market. Desiree further reported that it had been brought to her attention that the Health and Wellness October E-Blast may have violated the club's Standing Rule #13. #### Fig Garden Woman's Club General Meeting Minutes November 12, 2025

Welcome: President Desiree Ward welcomed the membership to the meeting.

**Collect:** Member Debra Riley led the members in reciting the Collect and the Pledge of Allegiance.

Song: Member Martha Stewart led the flag waving members in singing "It's a Grand Ole Flag."

**Inspiration**: Member Bobbie Kirk spoke about the blessings of service and how the best gifts are not wrapped in gift wrap but rather are wrapped in love, awareness, and intentions.

If These Walls Could Talk: Member Libby Borchardt read an excerpt written by Member Susan Pappas about the history of the Club. The building of the clubhouse started in 1921 and was completed in 1926. On March 4, 1926, the clubhouse was formally dedicated. According to the Fresno Morning Republican, six of the charter members were present at the dedication and the Spanish-type building cost \$10,000. The color green was chosen, the motto was "Home and Community," and the Club was dedicated to service to home, the federation, and the community.

**Introduction of Guests**: Club members introduced six guests.

**Memorial Program:** Member Kim Gould led a tribute to six members who passed away during between June of 2024 to June of 2025. There was a moment of silence for those members who were Mary Vaughan, Midge Barrett, Carol Scott, Maria Helena Prochazka, Mary Lou Zazzo, and Janet Hill. Family members were present for Mary Vaughan and Janet Hill. Janet Hill's daughter Member Cindy Hill provided champagne and made a toast to the recently departed members and to all mothers past, present, and future

Program: Member Hope Rosky introduced Senior Master Sergeant (Retired) Sabrella Bacon and her female guests who have been in the armed forces. Ms. Bacon joined the U.S. Air Force in August of 1987 and retired in 2014. The theme of her talk was "Your Mama Wore Combat Boots" and she spoke of the importance of having women in the military. Ms. Bacon informed the membership that women weren't accepted into full-time positions until 1948. Previously, women were only admitted to fulfill certain positions like nursing needed during wartime. While serving, she was a bioenvironmental engineering technician. Ms. Bacon ended by quoting former President Ronald Reagan, "Freedom is never more than one generation away from extinction. We didn't pass it to our children in the bloodstream. It must be fought for, protected, and handed on for them to do the same, or one day we will spend our sunset years telling our children and our children's children what it was once like in the United States where men were free."
